



1. Guarantee

By executing this Deed and in consideration of *That's Amore Cheese* agreeing to grant credit facilities to the Customer, we the undersigned do hereby jointly and severally:

- a) Guarantee the due and punctual observance and performance of the Terms and Conditions by the Customer, including the payment of all monies now and hereafter owed by the customer/applicant to *That's Amore Cheese*.
- b) To accept liability for all costs, charges, commissions, fees and disbursements incurred by *That's Amore Cheese* in recovery of any unpaid account.
- c) To acknowledge the right of the *That's Amore Cheese* to withdraw the credit facilities offered to the customer/applicant, vary the terms of this credit application or place a limit on the amount of credit available to the customer/applicant at any time by giving notice to the customer/applicant without prejudice to any other rights that *That's Amore Cheese* may have and without being liable for any loss or damage of any kind suffered by the customer/applicant as a result.
- d) To notify *That's Amore Cheese* no later than 14 days prior to any change or intended change of ownership. Failure to do so could result in the customer/applicant being responsible for future debts of the new ownership. Credit facilities will not be automatically transferred to the new owner.
- e) The property of the goods shall not pass until full payment of the purchase price. All risk for loss or damage after is to the purchases account.
- f) Agree to be bound by the Terms and Conditions of Trade in force between *That's Amore Cheese* and the Customer.

- With any issues relating to the integrity of *That's Amore Cheese* product/s, please call within 48hours of delivery to obtain a returns notification number. A photo of the product may be required in order to verify claims and offer customer/applicant a credit for product with integrity issues.
